THE ORGANIZATION EDUCATED THE PUBLIC ON HOW PROPERLY TO ADVOCATE FOR MARRIAGE AND DEBATE IN THE PUBLIC SQUARE ON THE SENSITIVE ISSUE.THIS INVOLVED PRODUCING AND DISTRIBUTING RESOURCES ACROSS SEVERAL MEDIA PLATFORMS AS WELL AS HIGHLIGHTING MATERIAL PRODUCED IN THE POPULAR PRESS OR MEDIA. SPECIAL EVENTS WERE ALSO A COMPONENT OF THE MISSION, PARTICULARLY THE MARCH FOR MARRIAGE IN WASHINGTON, DC WHICH BROUGHT GRASSROOTS ADVOCATES , FAITH COMMUNITIES AND FAMILIES TO THE NATION'S CAPITAL.
